

Full Nondiscrimination Statement

Elections will occur at the 2022 Annual Meeting for one board seat representing the Central Region.

The Nominating Committee will meet from April through June at the DCEC office at 5 North Depot Street, Delhi, for the purpose of identifying candidates for the above position. The committee must be comprised of between 5 and 11 members representing the geographic diversity of the DCEC service area. Nominations for directors are governed by Article 4 of the Bylaws. A director may be nominated either through:

- The <u>NOMINATING COMMITTEE</u>. The Nominating Committee meets to identify at least two candidates to run for each seat up for election.
- 2) The second way is by <u>PETITION</u>. Any 15 or more members may petition the Cooperative to place a qualified member on the ballot. This must be done at least 45 days before the Annual Meeting.
