2024 Official Candidates & Voting Details

During this year's meeting, members will elect three members of the Board of Directors, one from each of the three Regions. There is one proposed bylaw change which you will find on page 6. Members will also vote for their **preferred charity**—however, all charities will receive an award. See charity details on page 7.

Each membership shall be entitled to cast only one ballot; for example, a joint membership has one vote. All questions shall be decided by a vote of a majority of the members voting thereon in person or by absentee ballot. Questions resulting in a tie vote shall be decided by a second round of voting in like manner. If a second round of voting results in a tie, the question shall be decided by a flipping of a coin, which shall be administered by a duly elected officer of the Cooperative. During the Annual Meeting, or by absentee ballot, eligible voters can vote for one (1) candidate from each of the three Regions. Please be aware that the members can vote for any of the three Regions even if they do not reside in that Region. For example, if you live in Kortright you are considered to be in the Central Region, so you may vote for one candidate from the Central Region AND one candidate from both the

Southern and Northern Regions.

NORTHERN REGION

Greg Starheim is a long-time resident of Schoharie County, having grown up on the family farm in Gilboa. After graduating from Jefferson Central School, Mr. Starheim went on to Clarkson University where he earned his B.S. in Mechanical Engineering and subsequently an M.B.A. from RPI. He is a licensed Professional Engineer in the State of New York.

Mr. Starheim has over 38 years of experience in the electric utility industry. After graduating from college, he spent 19 years working for the General Electric Company where he held various engineering and leadership roles throughout GE's global power and utility businesses. Upon leaving GE in 2003, Mr. Starheim moved back to the family farm to be closer to family and friends. He became active in the local community and the CEO & General Manager of the Delaware County Electric Cooperative, a position in which he served from 2003 to 2012. During this time, DCEC successfully invested in critical technology platforms and worked closely with state and county economic development officials to attract and retain industrial businesses to the area, including Amphenol Corp in Sidney.

After 8 years at DCEC, Mr. Starheim was named President & CEO of Kenergy Corp, a \$500M electric distribution cooperative serving western Kentucky. From there, he served six years as Sr. Vice-President of the National Rural Utilities Cooperative Finance Corporation (CFC), a \$30B financial services firm exclusively serving the nation's electric cooperatives. In his most recent role, Mr. Starheim was the President & CEO of the Delaware Electric Cooperative, a large regulated electric utility serving the majority of the State of Delaware. Mr. Starheim retired in February 2023 and returned to the area on a full-time basis.

Mr. Starheim and his wife, Elaine (Many), have four grown children. He is active in the Stamford Chapter of Rotary International and enjoys flying airplanes and working on the family farm.

CENTRAL REGION

Ross Gill has lived in the Delhi area with his wife, Athena, for 30 years and has been a member of DCEC since 2007. Ross has been a title insurance searcher, examiner and assistant underwriter for 32 years and currently works remotely for the American Title Insurance company. Ed Griswold My adult life began sometime during my second semester senior year of high school when the reality that my parents were financially incapable of funding my college education hit me. After my first year I had the good fortune to do part of my MS degree at the University of Dijon, in France and in 1990, become a recipient of the Nasa Honors Teacher Award which earned me an all-expense-paid month to work and collaborate with other states' recipients at the Stennis Space Center in Mississippi. Following that unforgettable experience, with three other recipients, we did a presentation on the then future International Space Station at the 1991 Annual National Science Teachers' Convention in Boston, MA.

By 1994, it was time to move on to something else; however, that "something else" was left in the hands of the Universe. Two beliefs have been the foundation of my life: 1) the energy one sends out to the Universe is returned in-kind, and 2) if one has a talent or gifts/he has an obligation.

In March of that same year, two influential people entered my life. They were both financial planners and we decided to build a team which meant new schooling and exams in securities, life and health insurance, and registered investment advisor were needed for proper licensing. By May of 1995, those goals were achieved and my second/current career as a self-employed, wealth planner/manager was launched.

Community service is an excellent way to meet one's "obligation". In the fall of 2017, the Trustees of the College Foundation at Delhi accepted me as one of its trustees and in January of 2021, elected me president (volunteer position of a 501c3 non-profit) to oversee the \$6M physical assets, \$15+ M financial/invested assets, educational initiatives, and coordinate the many committees.

SOUTHERN REGION

Jeffrey Russell is a Walton native who resides on his family's multi-generational farm with his two children (Madilyn & Liam). Jeffrey works for the Delaware County Soil and Water Conservation District where he is an Engineering Technician in the Stream Program. He has been on the board of directors for two terms where he has served as the Vice President for the past 4 years. He chairs the Organization & Staffing Committee and is a Credentialed Cooperative Director.

2024 Proposed bylaw change

Proposed bylaw amendments to Article IV, Sections 3 & 6: Additions are noted in red and underlined:

Section 3. Nominations. It shall be the duty of the board of directors to appoint, not less than ninety (90) days nor more than two hundred (200) days before the date of a meeting of the members at which directors are to be elected, a committee on nominations consisting of not less than five nor more than eleven members who shall be selected from different sections of the project area so as to insure equitable representation. No member of the board of directors may serve on such committee.

The committee, keeping in mind the principle of geographical representation, shall prepare and post at the principal office of the Cooperative at least sixty (60) days before the meeting a list of nominations for directors. The committee shall make its best efforts to ensure that their list of nominations is comprised of at least two nominees per vacancy from each region or area of the Cooperative having one or more vacancies on the board. However, in the event that the committee is unable to secure and propose two suitable nominations for a vacancy, the committee may put forth a single nominee so long as the committee has completed and documented its best efforts to secure two nominations. Any fifteen or more members acting together may make other nominations by petition not less than forty-five (45) days prior to the meeting and the Secretary shall post such nominations at the same place the list of nominations made by the committee is posted. The Secretary shall mail with the notice of the meeting or separately, but at least seven days before the date of the meeting, a statement of the number of directors to be elected and the names and addresses of the candidates, specifying separately the nominations made by the committee on nominations and also the nominations made by petition, if any. Additional nominations made by petition shall be for the respective region having vacancies on the board to be filled at the annual election. At the meeting, members shall each cast one vote for every vacancy in each region. If, for example, there are two vacancies in the Northern Region, each member may cast one vote for each of two nominees on the list, for a total of two votes. The nominee, or in the case of multiple vacancies, nominees, in each region receiving the most votes cast shall be deemed elected to the board of directors. In the multiple vacancy example, that would mean that the nominee receiving the most, and the nominee receiving the second most votes would become directors. Notwithstanding anything contained in this section, failure to comply with any of the provisions of this section shall not affect in any manner whatsoever the validity of any election of directors.

For nominating committee purposes in this Article IV, Section 3, a "vacancy" shall mean a Board seat that is up for election in the relevant year and is to be filled through the election process. For the avoidance of doubt, the nominating committee shall not convene or propose candidates for vacancies created by reasons other than the scheduled end of a director's term.

Section 6. Vacancies. A vacancy occurring in the board of directors by reason other than the scheduled end of a director's term (i.e., death, resignation, removal) may be filled by the affirmative vote of a majority of the remaining directors. The director appointed in accordance with this paragraph must meet the director qualifications as set out in Article IV, Section 2. The appointed director may serve for a term ending no later than the next annual meeting of the members. In cases where the term of the vacated seat would have extended beyond the next annual meeting of the members, a special election shall be held at the next annual meeting of the members to fulfill the unexpired portion of the term of the director in respect of whom the vacancy occurs. The nominating committee for that year shall nominate candidates for the special election in the same manner as the committee would for a regularly scheduled election.

DCEC has teamed up with CoBank's Sharing Success program, a provider of banking services, to donate \$2,000 to three nonprofit organizations. The Cooperative received nominations for the following charities:

The nonprofit with the most votes will receive a check for \$1,000.

The nonprofit with the second most votes will receive a check for \$600.

Lastly, the nonprofit with the third most votes will receive a check for \$400.

VOTE BY MAIL: One method for a member to vote is by absentee ballot. Request an absentee ballot by completing the official form below and submit to DCEC by **August 4, 2024**. Once the Cooperative receives your form, we will provide you with an official absentee ballot which you can then complete and send back to the DCEC office. DCEC will count properly completed absentee ballots as long as they are received by **August 20, 2024** (four business days prior to the Annual Meeting). Once DCEC has received a member's absentee ballot, it cannot be revoked. A member voting by absentee ballot may still attend the Annual Meeting, however, can not vote again.

VOTE EARLY AT THE CO-OP OFFICE: Members can also complete an absentee ballot in person at the Co-op office during regular business hours between **July 29 and August 20, 2024**. You must have a government issued photo ID with you to vote by absentee ballot in the Cooperative office.

Reporting Outages

Members, please always report when you experience a power outage. There are some cases when a member has a single outage and we may not know unless you report the outage. Likewise, if an outage is widespread, the more members that report the outage, the more information this provides for our Line Crew to find the cause of the outage to restore power. Providing information such as where trees are down on the line or "hearing a pop" are helpful to relay to us to quickly diagnose and restore the outage.

To keep members in the know when there is an outage, we have been posting on our Facebook page and sharing to many local group pages with updates throughout the four counties we serve. We strive to get you information as it is discovered in the field so that our members know how long the outage may last for.

Cooperatives are not-for-profit, member-owned businesses. Electric utility cooperatives build and maintain three times the miles of power line of other utilities and do so at comparable rates despite fewer customers. They do this by operating on a not-for-profit, cost-of-service basis.

Once a member pays the membership fee, they become a part owner of the cooperative. They have a voice in how the Cooperative is operated and influence this process through casting their vote at the annual meeting. It is also at the annual meeting that the members elect DCEC's seven-member board of directors from the membership.

Because the members of the Cooperative are also the owners this means the cooperative is locally owned and operated. Employees of the Cooperative are also local residents who are familiar with the needs of the communities they serve.

Third Party Notification

Every member has the right to designate a third party to be notified if the member's bill is not paid and if the member's service becomes subject to disconnection for nonpayment.

For example, a parent can designate an adult child as the third party to receive notifications. Third party notifications can be very helpful in situations where health troubles or other factors might make it difficult for the member to stay on top of bill payments.
