

Potential Hazards of Underground Utilities and How to Dig Safely

Because Digging Season is officially here DCEC urges Members to know before you Dig!

Don't make that judgement call, instead make two calls:

- 1.) Dig Safely New York Call 811 before you dig.
- 2.) Call DCEC because secondary lines are not listed with Dig Safely New York. DCEC crews are able to locate underground for members upon request. Please call (607) 746-2341 to confirm if your service location has underground and the proper safety procedures.

There are potential hidden dangers and the Co-op urges Members to please call and don't make assumptions whether or not their service location has underground. Every digging job requires a call - even "small" projects like planting trees and shrubs, installing mailboxes, hiring a contractor or landscaper to do a digging project. Failure to identify location of underground utilities can result in damage to gas, electric, communications, water and sewer lines, which can lead to service disruptions, serious injuries or even death and costly repairs and fines.

Go 100% GREEN with DCEC

Did you know that approximately 90% of the power distributed by Delaware County Electric Cooperative (DCEC) comes from the Niagara Project, which is a source of clean hydro renewable electricity? The Co-op has developed a program for members to become 100% Green if they choose. The program is called GO 100% GREEN and will be available in September of this year. This program allows the other 10% of incremental power purchased for you by your Co-op to be environmentally friendly. The source of renewable energy for the GO 100% GREEN program is a landfill gas energy project owned and operated by fellow cooperative, Steuben Rural Electric Cooperative, in Bath, NY. Please keep in mind that DCEC's GO 100% GREEN is completely voluntary. If you choose, this would be an easy and affordable option to support renewable energy directly through your electric bill. There is no cancellation fee and you can terminate this program at any time. This program allows the member to purchase Renewable Energy Credits monthly, which will depend on the member's total monthly kWh usage. The 2016 cost will be only \$0.006 per kWh of use.

Your Commitment to a Cleaner, More Sustainable Energy Future

The Cooperative is very fortunate to have a 90% renewable power supply sourced from clean hydro power at Niagara Falls. With our good fortune comes a responsibility to utilize that precious resource wisely. Wise use of our hydro power comes in four forms:

conscious of your energy choices. No special tools or studies are required.

Conservation: Conserving energy means only using energy when it is truly useful to you. The simplest example of conservation is turning off lights when you're not in the room. Other forms of conservation can be a little less convenient, like unplugging electronics or appliances that will be unused for a period of time. Still other forms of conservation can border on uncomfortable, like reducing the temperature on your thermostat in the winter season. Your key to energy conservation is to listen to your own common sense and be

Efficiency: Efficiency means using the right tool for the job so you can do it with the least amount of energy. The low hanging fruit for many of us is LED lighting instead of traditional incandescent bulbs. Bigger gains in efficiency may be available in your home if you have old inefficient appliances, heating sources (boiler or furnace), insufficient weatherization and insulation, or if you run inefficient motors on your farm or business. The key to these efficiency gains is identifying the inefficiencies and targeting them. The Cooperative can help you to do that by getting you a free or low-cost home or farm efficiency study, funded through the New York State Energy Research and Development Authority (NYSERDA) or the United States Department of Agriculture (USDA). Vote by Absentee Ballot

If you are not planning to attend the 2016 DCEC Annual Meeting, you can still make your vote count by requesting an absentee ballot. One method for a member to be eligible to vote by absentee ballot is to request a ballot by completing an official form (available below) and submit it to the Cooperative by September 2, 2016. Once the Cooperative receives your form we will provide you with an official absentee ballot which you can then complete and send back to the DCEC office. DCEC will count properly completed absentee ballots as long as they are received by September 19, 2016 (4 business days prior

to the Annual Meeting). Once DCEC has received a member's absentee ballot it cannot be revoked if the member decides to attend the Annual Meeting and vote once there.

Members can also complete an absentee ballot in person at the Co-op office during regular business hours between September 2, 2016 and September 19, 2016. You must have a government issued photo ID with you to vote by absentee ballot in the

would like more details.

More Renewables: Believe it or not. part of our responsibility as stewards of our hydro power is to supplement it with even more renewable energy. If you are interested in personally going 100% green, you can invest in your own distributed generation resources like solar panels at your house or you can participate in the Cooperative's Go 100% GREEN program so that all of your electricity needs can be met renewably. For those interested in their own solar panels at their home, please note that the NY Sun program still has a small amount of funding available to assist you. You are also still eligible

for federal and state tax credits to help offset your cost to install solar panels. Call the office if you would like more details.

Smart Grid: New York State's Smart Grid initiatives are intended to meet everyone's electricity needs without constantly expanding the capacity of the grid through tens of billions of dollars of investment. The Smart Grid will take many shapes in the next decade including distributed energy storage and demand response programs. The Cooperative has had a Smart Grid program in place for over 20 years called the Hot Water Heater Load Control Program. If you have an


electric hot water heater and use at least 350 kWh per month, you can participate in this incredibly effective program, which shifts member electricity demand away from peak times. Participating members receive a \$4.00 credit each month. Call Wayne at 607-746-9284 for more information.

Not every member of the Cooperative has to participate in all 4 of these areas, but each one of us should make a commitment to make our own contribution to the effort. Please take stock of your energy consumption and make a commitment to the changes that fit into your life. Become a part of a cleaner, more sustainable energy future.

Dangers of Unauthorized Pole Attachments

Do you have a satellite dish, bird feeder, clothes line or any other kind of unauthorized attachment to the Cooperative's utility pole near you house? If you do, you are not alone. Unfortunately these unauthorized attachments pose a threat to the safety of line workers when they must climb a pole to perform maintenance or restore power after a storm. Under OSHA regulations enacted in 2014, a line worker needs to utilize a fall restriction device that wraps around the pole as he climbs. Each time a line worker reaches an unauthorized attachment, he needs to remove the fall restriction device from the pole to climb past the obstruction, placing the worker at increased risk for a fall. Please do your part to keep our workers safe. If it can be done safely, remove any unauthorized attachments from the utility poles near your home. If you need help removing an attachment or you don't know whether an attachment is authorized, call the Cooperative's office at 607-746-2341. We would be happy to assist you.

The Cooperative will be observing a grace period until September 1, 2016 to allow members to remove unauthorized attachments from the Cooperative's utility poles. After September 1, 2016, Cooperative personnel will be instructed to carefully remove any unauthorized attachments that they come across in the normal conduct of their duties.

working in the Gilboa area on Bund, Meeghan, Todd, and Souer Roads. Cooperative crews will be clearing right of way easements in the Town of Davenport & Harpersfield on Tedle Brook, Quaker Hill, Rose Lane, and Parker Schoolhouse Roads.
